These individuals shall serve a two (2) year term of office commencing July 1st of the election year and shall serve for two (2) years. *Elections for President and Vice President will occur on odd number years, and election for Secretary/Treasurer will occur on even number years.*

- Amendment approved in first round of voting, and will be voted on again at June meeting for final approval.
